FIREWORKS ON THE 4TH: WHAT YOU NEED TO KNOW

In Colorado, the laws regarding fireworks are quite specific and vary depending on the local jurisdiction. Here is a general overview of the regulations:

Statewide Regulations:

- **Permitted Fireworks:**
 - Only fireworks that do not leave the ground or explode are generally allowed. This includes items like sparklers, fountains, ground spinners, and smoke bombs.
- **Prohibited Fireworks:**
 - Fireworks that leave the ground, explode, or contain more than 50 milligrams of explosive composition are prohibited. This includes firecrackers, bottle rockets, roman candles, mortars, and similar items.

Local Regulations:

Many cities and counties in Colorado have stricter regulations than the state law. It is important to check the local ordinances in your area. Here are some examples:

- **Denver:** All fireworks, including sparklers and fountains, are illegal.
- **Colorado Springs:** All fireworks that explode, emit a loud noise, or leave the ground are illegal. Only novelty items such as sparklers, fountains, and ground spinners are permitted.
- **Fort Collins:** Similar to state law, only non-explosive, non-aerial fireworks are allowed.
- **Boulder:** All fireworks are illegal, including sparklers and fountains.
