NEW COLORADO LAWS FOR SAFER ROADS

This year, Colorado has rolled out several important updates to traffic laws designed to reduce crashes and protect everyone on the road—especially cyclists and pedestrians.

- As of **January 1, 2025**, all drivers are now prohibited from holding or using handheld devices behind the wheel—even when stopped at red lights. First-time offenders face a **\$75 fine and two license points**, with increased penalties for repeat violations.

- Also new this year: drivers who **weave in and out of express lanes** on I-25, I-70, or US-36 outside designated zones now face fines of up to **\$250**, as improper lane changes have been a leading cause of high-speed collisions.
- Locally, **Fort Collins passed an ordinance in June banning unreasonable vehicle noise**, including revving, tire squealing, and excessively loud music—reinforcing the city’s commitment to safer, more peaceful streets.

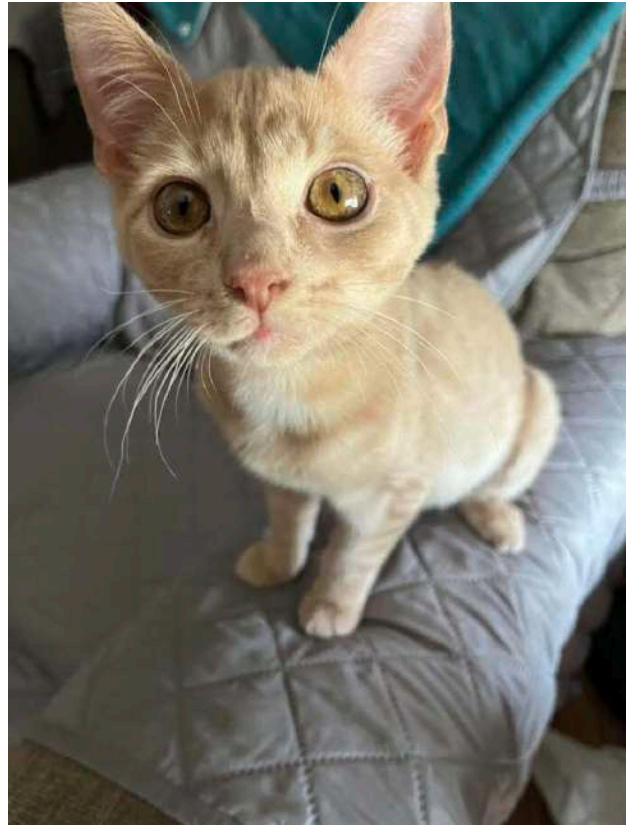
