CASE SUCCESS STORY

Our client, an active and involved Doctor of Dentistry, was rear-ended at a stop light in Windsor, Colorado while waiting for a child to cross Main Street. Prior to this collision, our client had a robust medical history, including spinal fusion surgery and prolonged medical treatment for her neck.
